General Guidelines

- The Parade will start promptly at 4:00 p.m.
- Parade participants travel east on La Piedra (the parade route) and must turn right (south) onto Menifee Rd. to exit the Parade. (Map attached)
- All participants are encouraged to show their patriotism by incorporating a patriotic theme into their entry. **All groups must stop at the Judges station for no more than a 2 minute performance--categories for judging are Original, Patriotic, and Humor. Winners will be announced at 6pm to receive their trophies on stage.**
- Participants who will be throwing any object, including candy or handing out any information, must be on foot, outside the vehicle and walking at least 5 ft. from any vehicle. Failure to follow this rule could result in your removal from the parade. We want to provide participants and spectators safety from moving vehicles.
- Every participant in your group must complete both liability waivers. They must be submitted prior to the day of the event. Lake Menifee Women's Club Waivers email to joinLMWC@gmail.com. City of Menifee Waivers can be dropped off at the Kay Cenicerros Senior Center, 29995 Evans Road, Menifee, Attention Aisha Jemmott Wilson.
- Lake Menifee Women's Club reserves the right to deny access to any parade entry that does not satisfy these guidelines.
- Please provide a group name and a brief description for MC announcement. All groups must stop at judge's station for no more than a 2 minute performance.

Staging Location & Time

Staging will be at the **Mt San Jacinto College Parking Lot** entrance off **Antelope Road. La Piedra Road will be closed.**

Staging Time: Check in will begin at **2pm**. Please plan on arriving at the staging area no later than 3:30pm. Participants will be turned away if they arrive later than 3:30pm.

Check In: Please have a representative from your group check in upon arrival for your staging number. Check in will be located at the **Entrance off Antelope Road. You must check in to get your spot number. Lake Menifee Women's Club and City Waivers must have been received prior to this day.**

******Please note: La Piedra Rd will be closed, so you will need to enter the college parking lot from Antelope Road.*** Car Clubs and Horses can utilize inner circle road off of La Piedra Rd for staging.***

Recommendations: It will most likely be hot. We recommend you bring water to stay hydrated and some sort of shade to cover you while you wait. You are responsible to remove all trash and items by 3:30 p.m.

Parade Route: The parade route is only the length of La Piedra Road (see attached map). Participants will stop at the Judge's table for a brief performance. Once you arrive to the corner of La Piedra and Menifee Road, you are at the end of the parade. You must exit by turning right onto Menifee Road. All parade participants are to return to the parade staging area by taking Menifee Road to Holland, head west and right onto Antelope Road then into the parking lot (please follow detours, if applicable).

Once you exit the parade route, you must follow all normal traffic laws and proceed with caution.

Independence Celebration Parade Route 6/29/2024



La Piedra Road will be closed to public vehicles from 6 AM to 10 PM. All parade participants will park **P** in the labeled parking areas entering from Antelope Road following the white or yellow arrows into MSJC parking lot prior to meeting at the staging area/loop. Once in staging area, wait for instruction from Lake Menifee Women's Club member. Parade will start on La Piedra Rd. and head east following green **➡** arrows. The parade ends **📍** at the intersection of La Piedra Rd. and Menifee Rd. To get back to the parking lot and enjoy the rest of the event, follow the yellow **➡** arrows to return to the parking lots. From there walk down La Piedra Rd until you reach the grassy area of Wheatfield Park. Be safe and have fun!

Signage Requirements

1. All participants are required to have signage that clearly identifies their group/organization. This can be in the form of a banner or a sign.
2. Walking/pedestrian groups are required to have group uniformity (i.e. uniforms, matching clothing, logoed clothing (hats, shirts, etc.).
3. If you are using a vehicle in the parade, your group is required to have either a banner walked in front of the vehicle or signage on each side of the vehicle.
4. **Vehicle signage - recommend be at least 18"x 24" in size.**
5. **Banners walked through the parade must be at least 18" x 36" in size.**
6. If you have an existing sign or banner, attach photo with application for approval. Please email a picture AND signage dimensions to joinlmwc@gmail.com.

Sign Order Information

If you do not have a sign, we ask you to use our preferred vendor, RAR Designs.

1. Two magnetic signs for cars can be ordered and purchased at RAR Designs.
2. Orders must be placed no later than June 1, 2024. You are responsible for payment and confirming that all your information is correct.
3. Participants are responsible for picking up and bringing their signs to the parade staging area.
